- Beginning Tuesday, April 13th the TK-5th grade students will start attending 5 days a week with breakfast starting at 7:50 and students picking up their lunches to go home between 1:20 and 1:30. The instructional time will be 8:00 to 1:20 daily with a built-in 20-minute snack break the para-educators and noon duty supervisors will cover.
- Students in Grades 6th-8th will remain in the Hybrid AM/PM schedule with 3 classes on site and 3 classes in Distance Learning.
