**2.     REPORTS AND COMMUNICATION**

**2.1     Superintendent's Update – Craig Guensler**

- Superintendent Guensler congratulated Wheatland Elementary and Wheatland Charter Academy for being honored as STAR Schools on the Honor Roll for Education Results Partnership. ERP goes through student data to identify schools who are closing the achievement gap and getting kids to grade level.
- Mr. Guensler gave an update on the COVID numbers and a vaccine update. Education is being pushed back a bit as the county looks to vaccinate people in the 65 and older age ranges first. This could potentially push us back to late Spring.
- The District is taking back our students from the County next year. We will be running our own SDC classes on the Wheatland Elementary and Bear River campuses. Because we have so few students in these classes, we will likely take Plumas Lake Elementary District's SDC students too. Three of the county teachers have agreed to come work in those classes. Superintendent Guensler thanked Angela Gouker and Erin Oakes for working through the process with him.
- The lease of Virginia School is complete.
- Superintendent Guensler and Tara Aroz are in the planning and discussion stages for Summer Camp and what it will look like this year. They are hoping for an onsite program. Summer camp may be more like a summer school program to help with some of the learning loss. The thought is the program can be more of an academic catch-up rather than enrichment as in the past. They are considering the number of kids they can accommodate and which campuses the summer school program will take place from.
