The plan will be presented at a public hearing at the Districts Board of Trustees May 20, 2021 board meeting for stakeholders, including parents and district staff to discuss and provide any feedback with the purpose of promoting plan involvement prior to the plan adoption at the Board Meeting on May 27, 2021 (in order to meet the June 1 deadline). The district will send this draft plan to the bargaining units for any added input. The Superintendent will also collaborate with the site Principals in order to gain their insight on the plan, where principals will further discuss with their staff and other stakeholders. This plan will be submitted to the District's Board and the Wheatland Charter Board for approval prior to June 1, 2021 deadline, however, it could change in the future given additional stakeholder input and additional data. The plan will be continually updated to include the actual expenditures on or before December 1, 2022.

A description of how students will be identified and the needs of students will be assessed.

The district will utilize the state testing assessment program to measure student proficiency and growth. The district will also seek information from the teaching staff on students that can benefit from additional learning opportunities for supplemental instruction and support. These two tools along with counselor, psychologist, administrators and other staff input allows the district to measure and determine evidence based services for our most needy students. We will identify learning growth areas and then formulate the interventions needed to help close these achievement gaps.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

The adopted Expanded Learning Grant Plan will be posted on the district and school websites and shared at stakeholder meetings (i.e., ELAC/DELAC, School Site Councils, Parent Advisory meetings, etc.). Moreover, as the plan services become available, such as after school expanded learning, counseling and Summer School Opportunities, it will be communicated out by site staff to students and families.

A description of the LEA’s plan to provide supplemental instruction and support.

The district will continue to include in the master schedules at each site, intervention time in order to have focused remediation services for students based on identified needs and state testing results. The district will look at increasing contracted hours and/or employing additional staff to concentrate on the focused areas. We will increase our para educator staff hours to meet the needs of our youngest students and possible add time to our other grade levels. Also, typically we hold a summer camp each year but we will look to add supplemental instruction and support to the summer program in June of 2022. These services will be educationally based programs to help build the skills of the identified students. The district will look at integrated support services such as counseling and Mental Health Counseling services as a key area and available to all district students.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The Wheatland School District and Wheatland Charter Academy will coordinate the use of the Expanded Learning Grant and other federal ESSER funds by budgeting all funding sources across several categories to best meet the needs of the local district, staff, students and community. In 2021-22, The Expanded Learning Grant funds are primarily budgeted towards dedicated student support and learning recovery programs in order to accelerate progress towards closing the achievement gap, diagnostic assessments and progress monitoring; integrated student services such as counseling; and paraprofessional staffing. In 2021-22, the ESSER funds are primarily budgeted towards other school and district needs and improvements to reduce the risk of virus transmission and to support student health needs as well as mental health services and counseling supports. Then, in 2022-23 and beyond, the ESSER funds are planned to also be budgeted towards mental health services and counseling supports, dedicated English Language Learner resources, paraprofessional staffing, COVID-19 testing costs, personal protective equipment, sanitation supplies, professional development efforts and other determined needs. .

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
