3.2 (I) WAIVER APPLICATION TO REOPEN TK – 5 CLASSES

WAIVER DRAFT

Superintendent Guensler started by telling everyone Yuba County is still in the highest level, purple (widespread) tier. We might hit red (substantial) by the middle of October and if that occurs, the waiver would not be needed. If we are in the red tier for two weeks, Districts can bring back all students, TK-12th.

Superintendent Guensler shared the waiver draft. It meets all the criteria. He believes the earliest start date could be October 19th, but only if we are able to get the waiver to Dr. Luu by next Friday. If the board approves the waiver, we will send it to YCOE for their input. If they do not suggest changes, the plan would be sent to Dr. Luu for her approval. If she has no questions, comments, suggestions, the waiver would be sent to the California Department of Public Health for their approval to reopen for our TK-5th grade classes.

Superintendent Guensler talked about the surveys that were conducted with staff and parents. The survey for staff is closed, but the survey for parents will be open through this Sunday at 5:00 p.m.
