2. REPORTS AND COMMUNICATION

2.1 Superintendent's Update – Craig Guensler

- Superintendent Guensler started the update by telling everyone we are trying out the new Owl Speaker. It's supposed to move to the person speaking, so we'll see how it goes.
- Mr. Guensler shared the attendance in the District is improving. The Independent Studies, from moving students into quarantine, has dropped off significantly.
- Bear River Middle School sports is wrapping up for volleyball and football and they are starting on basketball. An update was received yesterday that for basketball they will not have to wear masks while playing. Players and coaches will have to wear masks while on the benches as well as spectators. At this time, spectators are still being limited to family members only.
- The first dance, after a year and a half, will be the Halloween Dance. It will be held on October 28th from 5:30 to 7:30. They'll hold it in the quad, so it will be outside.
- Superintendent Guensler gave an update on the Caliterra Ranch. Infrastructure work is moving at a rapid pace. They are expecting a few models to be up and ready to show by the end of the year.

- The District has had a number of field trips. Students have gone to Fairy Tale Town, Yuba City for a Science Environmental activity and of course Bishop's. There's a couple more planned for the next few weeks.
- COVID testing has begun and is going very well. Superintendent Guensler is encouraging parents to get tested a day or two before a field trip and not to wait until the day of.
- Impact Aid forms went out electronically this year. Most of the families have already returned the forms. Craig wanted to remind everyone the survey forms are important because we do not receive property taxes for the houses on base.
- The District and Transportation Department will participate in the Annual Trunk or Treat in the parking lot in front of the Dollar General. It will be held on Friday, October 29th from 1:00 to 4:00.

2.2 [Enrollment Report](#) – Craig Guensler

We have 1349 students which is 69 more students than last year, 27 fewer than in September. There are 138 students in the preschool program. That's 50 more than last year. We have a total of 1487 in all, which is 119 more than we had last year.

Beale is also doing a Trunk or Treat event on October 22nd from 5:30 to 7:30. There's going to be a huge parade with 20 plus different agencies participating and that will be held on October 29th.

Annette will share information with the District regarding the Military Child of the Year Awards and the nomination process.
