**2.1 Superintendent Update – Craig Guensler**

- Superintendent Guensler introduced Lt Col Bobby Hale. He will be our new liaison with Beale and he'll be a big part of the board. Craig welcomed him and thanked him for being here.
- Superintendent Guensler took the opportunity to thank everyone for getting things up and running for the New Year. We've hired a few new teachers and are still in the process of hiring para educators.
- The two busses ordered last year arrived this week. Both are fully air conditioned and almost all of our busses have air conditioning now.
- We had a staff development day with a couple of snags with presenters not being able to present virtually, but it was handled well. Chad and the principals did a good job of organizing the day.
- Board President Crabb, Board Member Waltz and Superintendent Guensler visited the school sites and every classroom yesterday. He said it was nice to see the students in the classrooms and on the playgrounds. They observed lots of learning taking place. He gave Raegean and Nikki a chance to report on anything they saw. Raegean said it was nice to see the campuses full and lively again. Nikki thought the best part was seeing and watching the kids play. The laughter and normalcy was great to see. She thanked Craig for taking them to the schools.

- Yesterday we had some bus issues with Vassar Gate having only ingoing but not exiting traffic. It's been fixed now, so we shouldn't experience late busses again.
- The next board meeting will be on September 9<sup>th</sup>. It will be a week earlier than normal due to financials being due to the county before September 15<sup>th</sup>.
- Craig presented the Air Quality Index Chart and the rules we follow since we received a lot of questions and calls from parent about this because of the fires.

- There are 1376 students enrolled which is 74 more than last year at this time. The numbers are up and it's good and the reason why we've hired a couple of new teachers.

**5.5 (I) COVID GUIDELINES AND MASKING REQUIREMENTS –  
Craig Guensler**

- Craig shared a power point presentation. He started by talking about the changes with COVID 19 since last year. According to the State and health department the Delta variant is more contagious than any other variant. Also, according to the health department those infected by the delta variant who are unvaccinated have higher odds of hospitalization. He shared other information from the Health Department that shows that the State continues to make gains in vaccinating Californians however the state is experiencing a high rate of infection due to the Delta variant.
- August 11<sup>th</sup> the State ordered all teachers and staff must verify they are fully vaccinated. If they are not by October 15<sup>th</sup> they will have to be screened once a week for COVID testing. The district is currently collecting vaccination copies from employees and are looking for a testing vendor to work with.
- Superintendent Guensler reminded everyone the mandate is coming from the State. It is not a district mandate. Our current protocol is to offer a mask to all students who do not have them and ask them to wear it when they are indoors. Teachers are required to offer and encourage students to wear a mask. If the student does not wear one they will not be excluded and no discipline will be given. Superintendent Guensler asked that parents and guardians stop attacking staff in person and on social media about the masks. They are doing the best they can to follow the protocols and keep students safe.
- Parents, guardians, teachers and community members were given an opportunity to share their frustrations, ask questions or comment on how the start of school went.

**6. BOARD COMMENTS**

Board member Eaton felt like staff members were being attacked in tonight's meeting. She didn't feel like a board meeting was an appropriate place to bring forward complaints about staff. Craig explained the appropriate chain of command for concerns in the classroom or with an employee. Board Member Medina wonders how long we'll be doing the Zoom Meetings. Craig thinks Zoom meetings will be with us into the future. It's convenient for parents and staff. We'll need to work on getting the board room ready to return to electronically.
