**2.1 Superintendent Update – Craig Guensler**

- Superintendent Guensler was pleased to report the schools looked terrific yesterday as he and a few board members made their rounds visiting the schools for the first day back to school. The grounds and classrooms were clean. They saw big smiles on happy faces. He felt like this was the best first day in the last 10 years. People are seeing the positive of being back to a more normal school year.

**2.2 Enrollment – Craig Guensler**

- Enrollment was pulled on the 16<sup>th</sup> and at that time there were 1372 students enrolled in TK through 8<sup>th</sup> grade. We had 1282 at the end of the school year. Enrollment is up a full class at Wheatland Elementary. There are 371 students enrolled and attending at that site.
- The preschool enrollment is down a bit. We usually have many students enrolled from Marysville and Plumas Lake, but gas prices could be impacting the numbers as well as the extended birthdate for TK enrollment.

- September 16<sup>th</sup>, they are planning for the Recce Connect. It will be from 1:00 to 4:00 at the Club. They will have bounce houses for the kids and the USO will be there to perform. This will be a celebration of the Air Force's 75<sup>th</sup> Birthday.
- On the 9<sup>th</sup> of September, they are having a PDF Line at the Youth Center from 3:00 to 6:00. It will be a day for kids to simulate what it's like to go on deployment. The fire trucks will be there and they plan to have other fun activities for the kids.
