2.1 Superintendent Update – Craig Guensler

2.4 Retirement Recognition – Craig Guensler

- Peter Towne is retiring from Wheatland Elementary after 6 years as Principal. He has 39 years of service as an educator. He served as a teacher in the Rocklin School District, San Juan and Anderson Valley School Districts. He was a Principal in Eureka School District as well as in Greece with the American Community Schools. Peter is ready for some family time with his children, his stepchildren and some new grand babies. He and his wife are headed to Maui for a well-deserved vacation. We wish him well and want him to know how much we will miss his leadership in the District.
- Heather Slauzis was hired as a 1st grade teacher at Lone Tree School in 1996. She has spent the last 20 year in Special Education touching the lives of the students that struggle. Prior to being hired by our school district she did a long-term sub position in 1995-96 at Lone Tree School. At the time of her being hired she actually lived on Beale AFB.
