2. REPORTS AND COMMUNICATION

2.1 Superintendent Update – Craig Guensler

- Superintendent Guensler reported that the Renaissance Dinner on February 21st was a success, with the event raising approximately \$58,000.
- We had one person spend \$10,000 on two fire pits at Bishop's and she did this because she was a graduate of Bear River years ago and said her experience here was life changing.
- Thank you to Bishop's for adding two additional firepits to the evening.
- The Reni Rally on 3/11 for Wheatland El was highly attended, however they need a new sound machine. Lone Tree held their rallies outside on 3/12 and had great weather. In addition, they had a fourth-grade student who was recognized for reading two million words. Bear River's rally is tomorrow, 3/13 with 6-8th grade starting at 8:30am and 4-5th at 1:00pm.
- ASP- Summer Camp Enrollment begins 4/24 and goes through 5/1. After School Enrollment for 2026/2027 starts 5/22 at 4pm.
- Educators That Make a Difference Awards is on 4/23. We will have one veteran teacher, one new teacher and one classified staff member that will be recognized.
- Next Board Meeting is on April 16th.
- Amy Nore provided information on the County Fundraiser on April 16th - at Bishop's Pumpkin Farm- Farm to Feast. Students throughout the county will be providing side dishes.
- Upcoming Project: Lone Tree will be having their Fire Alarm System fixed.
- New Math Adoption for 2026/2027 School Year.

2.2 [Enrollment Report](#) – Craig Guensler

- There are 1355 Students enrolled, which is 13 less than this time last year and 4 less than last month.
- We have 76 students currently enrolled in our Preschool Program which is 21 less than last year and 2 more than last month.
- We have a total of 1431 in all groups. That's 34 less than we had at this time last year and 2 fewer than last month.

2.3 Yuba County Office of Ed. Superintendent Search Update – Rob Gregor

- Superintendent Rob Gregor reported there was information for Closed Session.
- There have been 3 meetings and we have met with Administrators, Teachers and Unions. There was a good turnout at Bear River it was nice to hear from the community.
- There have been a good number of people that have applied and expect a few more however the job closes tomorrow.

Superintendent Guensler explained it is a grant funded program and the District has to follow the guidelines for prioritizing who is accepted first. There is a real problem staffing the program as well.
