2. REPORTS AND COMMUNICATION

2.1 Superintendent Update – Craig Guensler

- Day 2 of Summer Camp #1 is complete and all is going well so far. The students are enjoying it. There has been no behavior issues and attendance is good.
- Next year's After School Program is basically full, with a few exceptions. There's a little room at Bear River in the upper grades.
- The end of year went well, and the 8th grade promotion ceremony was great. The student speeches were wonderful.
- We are holding off on new interdistrict request for next year's enrollment for Bear River and Wheatland Elementary in all grade levels. There's still space at Lone Tree.
- In August, we will be having another 2x2x2 committee meeting with the High School and the City of Wheatland. The discussions will be about building in town and the idea of a community pool. We will need two board members to be a part of this committee.
- Solar and Asphalt at Wheatland Elementary were hooked up. PG&E was on site on June 9th for the shut down so the solar could be connected. The asphalt repairs and updates are planned for the remainder of the week. The new bathrooms at the shop are nearly complete.

2.2 Enrollment Report – Craig Guensler

- At the time of the agenda, we had 1369 students. That's 27 more than this time last year and 5 less than last month.
- We have 95 students in our preschool program which is 3 more than last year and the same as last month.
- We have a total of 1464 in all groups. That is 30 more than we had at this time last year and 5 less than last month.
