At this time it was determined that Marcell needed to be searched as this did not follow his original story. Upon arrival at school Marcell came to the office and was directed to get his backpack. When he returned he was searched and no weapon was discovered. It was then reported that Marcell had a weapon on the bus and showed it to other students who then helped him hide the weapon upon arrival at school. The student holding the weapon was pulled from class and gave up the weapon during a search. Marcell will be suspended 5 days pending expulsion.

He said he didn't know why he brought it, but he liked it and liked playing with it. It was a toy gun. Admin took toy from him and spoke to him about seriousness of item. Admin spoke to superintendent. Student had not threatened anyone with the toy, had not hidden item when asked and readily handed it over. Admin left msg for mother who called back to speak to admin on 1/24. Mother spoke to student on eve of 1/23 and explained seriousness to him about bringing such a toy to school, why inappropriate and that he would have home consequences. Mother told admin she would not come to school to get toy gun and that student will not have such items at home. She advised admin to throw gun in trash and let student know. Admin spoke again to student. Student apologized to office staff for bringing this toy to school and said he understood after mother explained about school shootings to him why this was completely not okay to bring this toy to school. Admin updated teacher and superintendent.
