**2.1 Superintendent's Update – Craig Guensler**

- Superintendent Guensler started his update with sad news and a request for a moment of silence in recognition of the passing of Ramon Johnson who is the brother of Board Member Waltz. Ramon resided in the city of Wheatland for 54 years. He had been battling health issues for many years but finally lost the battle. There will be a celebration of life on February 6<sup>th</sup> at 1:00 p.m. at the Wheatland Community Center. He asked that we also recognize the passing of Congressman Doug LaMalfa. His services will be held on Saturday, January 24<sup>th</sup> at the Silver Dollar Fairgrounds in Chico.
- Monday is a holiday in remembrance of Martin Luther King Jr.
- February Break will be from February 9<sup>th</sup> – 16<sup>th</sup>. The District Office will be open with the exception of Thursday the 12<sup>th</sup> and Monday the 16<sup>th</sup>.
- The next Board Meeting is scheduled for February 19 at 5:00 p.m.
- He had some good news to share. The City Council approved the installation of a 4 way stop sign at the intersection of Wheatland Road and Oakley Lane.
- A few teachers have applied for small classroom grants that became available. Also, the Wheatland El PTC is getting items for the school like a new laminator and they are giving each teacher \$150.00 to spend for their classrooms.
